- **5.** To highlight about the role of law enforcement agencies for combating human trafficking.


3 RESEARCH METHODOLOGY

it is significant to offer about attention to this circumstance, for example this prohibition in himself generates the substance in Islam aimed at restraint of transition in individuals. The biosphere together protested against oppression, then this determination necessitate a cooperative struggle formerly yet again to eliminate the repetition of human trafficking or transition.
