Human trafficking is frequently attributed to factors like poverty, globalization, and economic inequalities between nations. Slavery's modern equivalent is human trafficking. The fight against human trafficking may be effectively carried out through international law. The UN Convention against International controlled crime is one of most respected and contemporary pieces of international legislation that has paved the way for how to identify, stop, and prosecute human trafficking. Pakistan has been mentioned as a significant cause, transition and terminus state for human trafficking and smuggling of the migrants, indicating a major sector and associated criminal economy. The current study focuses on examining how irregular migration from district Bahawalpur Pakistan, to Europe in specific, and to other EU member countries overall, is being assisted and coordinated via agents and social networks. Since Pakistan is reportedly one of the top ten nations which associated in illegal immigration to EU in contemporary years, irregular emigration become a substantial problem for Pakistan. Pakistan is regarded a transit country for migrant groups travelling from different South Asian nations to places like Iran, Turkey, Greece, Central Europe, and Western Europe. Illegal immigration become a major issue in Pakistan now a days and Pakistan has been nominated in the list of top ten countries who are involved in the illegal crime of immigration to the European countries in past few years.⁴

According to International organization of Migration 2020, an annual report was published in 2018-2020 that 79% of immigrants left Pakistan for Greece and out of these 46% are from South Punjab region. In first route some main cities of Pakistan such as Bahawalpur, to Rahimyar Khan, Karachi, and Lahore are the entrance points for Istanbul. The second way encompasses for Europe via Iran to Istanbul & Greece. This is the most dangerous paths due to its severe weather. Greek become the foremost route of illegal immigrants from Pakistan to Europe.⁵

- **2.** Develops the following policy for the National Archives NARA, including strengthening amnesty provisions for registrants after registering illegal immigrants.
- **3.** NARA, Training in the trafficking or transition of immigrants must include in the FIA Academy curriculum and provided prior to taking office by all officers.
- **4.** Undeveloped or progressive preparation in ideas associated to human trafficking or transition of Illegal immigrants are obligatory. It focuses on education in areas of illegal
- **5.** Create additional anti human trafficking cell offices within the Federal investigation agency, and produce subsidiaries in sections to cover a larger geographic area.
- **6.** Contemporary jurisdiction of Trafficking in Persons and Controls Ordinance (PACHTO) of 2002 is granted to national and local law enforcement agencies.
- 7. A separate law or regulation defines and criminalizes migrant Transition.
- 8. Prosecution of traffickers, migrant's smugglers, agents, brokers and transporters who are not smuggled illegal immigrants or victims of human trafficking. Prosecute family members who allow trafficking in children or smuggling children. Increased burden on law enforcement agencies to prosecute criminals.
- **9.** Try to create human rights-based integrated services for victims of human trafficking.
- **10.** These establishments will advance law enforcement recital by providing technical assistance, partnerships and supportive community engagement.
- **11.** By promoting the info for exposing myth or deceptions related to illegal immigration. This is made possible by providing resources in Urdu, Punjabi, Sindhi and other local languages to engage public influential, city

- **12.** Federal investigation Agency must promote community attentiveness about human transition or trafficking, especially among important authorities.
- **13.** Amend the Trafficking Prevention and Eradication Rule (TPER) which clarify Human Transition separated from migratory trafficking.
- **14.** Anti-Trafficking Centers in Pakistan must implement a standardized data collection system.

8 **RECOMMENDATIONS FOR FURTHER RESEARCH**

Here I identify five specific areas for further study of migration related to future policy work.

First, existing data such as census and household census allow further work on immigration issues. It may also be useful to use other sources of census and secondary data, along with more basic quantitative and qualitative data on specific migration issues. For example, according to the census, about a quarter of Pakistan's history of immigration is women who migrated for marriage. This requires more work with both quantitative and qualitative data. Another area where existing data can be used more effectively is the correlation between migration and ethnicity.
